THE MARGINALIZED FISHERMEN OF THE MUNICIPALITY OF
BULALACAO, PROVINCE OF ORIENTAL MINDORO**

"WHEREAS, the Constitution of the Republic of the Philippines mandates the State to protect the rights of subsistence fishermen, particularly of local communities, to the preferential use of local communal marine and fishing resources, and to provide support to such fishermen through appropriate technology and other livelihood alternatives;

"WHEREAS, Republic Act No. 8550, as amended by Republic Act No. 10654, otherwise known as the "Philippine Fisheries Code of 1998", empowers the Bureau of Fisheries and Aquatic Resources (BFAR) to implement programs and projects that enhance the productivity and sustainability of the municipal fisheries sector and improve the socio-economic condition of marginalized fisherfolk;

"WHEREAS, the Municipality of Bulalacao, an archipelagic municipality situated in the southernmost part of Oriental Mindoro, relies heavily on fishing as a primary source of livelihood for a significant portion of its population;

“WHEREAS, a considerable number of fisherfolk in Bulalacao are classified as marginalized, facing challenges such as limited access to modern fishing technology, vulnerability to climate change impacts like strong typhoons, high operational costs, and the ongoing need for sustainable alternative income sources;

“WHEREAS, BFAR has existing programs and funds allocated for the provision of essential livelihood interventions, such as the distribution of fishing gears, FRP (Fiberglass Reinforced Plastic) boats, post-harvest equipment, and capacity-building training, which are crucial for enhancing the resilience and economic stability of the local fishing communities;

“WHEREAS, the Local Government Unit (LGU) of Bulalacao, through the Municipal Agriculture Office, has identified specific needs that, if addressed with BFAR's assistance, would significantly improve the quality of life and productivity of the marginalized fishermen; Now, therefore, be it...
