deploy health professionals, including dentists, to Rural Health Unit (RHU)
within the Province of Oriental Mindoro;

"WHEREAS, the Local Government Code of 1991 mandates the delivery of
basic health services to the people, including dental care, as an essential
component of public health;

"WHEREAS, the Rural Health Unit (RHU) of Bulalacao, Oriental Mindoro,
currently has no assigned dentist, thereby resulting in limited access to dental
services for its constituents, particularly those belonging to underprivileged
families and residents of far-flung barangays;
