RESOLVED, to approve the following Appropriation Ordinance:

APPROPRIATION ORDINANCE No. 3
SUPPLEMENTAL BUDGET NO. 2

APPROPRIATING THE SUM OF ₱3,000.00 TO BE TAKEN FROM SUPPLY AND MATERIALS, WHICH WAS APPROPRIATED UNDER MUNICIPAL ANNUAL BUDGET NO. 1, S. OF 1985, AND ₱1,483.06, TO BE TAKEN THE UNAPPROPRIATED BALANCE UNDER SUPPLEMENTAL BUDGET NO. 1, S. OF 1985 FOR THE CONSTRUCTION OF THREE DOOR MUNICIPAL HIGH SCHOOL BUILDING AND IMPROVEMENT OF RADIO ROOM, THIS MUNICIPALITY

SECTION 1. There is hereby appropriated the sum of ₱3,000.00 and ₱1,483.06 for the construction of three door Municipal High School Building and improvement of Radio Room, respectively, this municipality;


SECTION 2. This Ordinance shall take effect immediately, after its passage;
