RESOLUTION REQUESTING HIS EXCELLENCY PRESIDENT FERDINAND E. MARCOS, MALACANANG, MANILA, AUTHORITY TO PURCHASE ONE (1) SERVICE JEEP FOR THE EXCLUSIVE USE OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO

WHEREAS, the municipality of Bulalacao is located in the Southernmost of Oriental Mindoro and thirty six kilometers away from the nearest municipality;

WHEREAS, there is no government physician nor private practitioner assigned in this municipality to render medical services;

WHEREAS, patients in this town who cannot afford to hire vehicles in going to Roxas General Hospital, Roxas, Oriental Mindoro die without seeing a Doctor;

WHEREAS, one government service jeep to be used in all emergency cases in this municipality is indispensable;

NOW, THEREFORE, on motion by Hon. Ulpiano C. Pandino, duly seconded by Hon. Jose P. Paigao, be it;






