RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 8 ✓

REQUIRING MEAT VENDORS TO PAY ₱0.30 FOR EVERY KILO OF MEAT SOLD IN THE PUBLIC MARKET

SECTION 1. All meat vendors selling meat in the Public Market are hereby required to pay ₱0.30 for every kilo of meat sold thereat;

SECTION 2. Violation of this Ordinance or parts thereof, shall be fined the amount of ₱500.00 and above but not more than ₱1,000.00 and imprisonment of one (1) to six (6) months or both such fine and imprisonment at the discretion of the court;

SECTION 3. Ordinances or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 4. This Ordinance shall take effect immediately.
