RESOLUTION REQUESTING THE MINISTRY OF TRANSPORTATION AND COMMUNICATION, MANILA TO DISAPPROVE THE APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE TO STO. DOMINGO SHIPPING LINES FLYING CALAPAN-BATANGAS AND VICE VERSA

WHEREAS, it was learned from reliable sources that the Sto. Domingo Shipping Lines plying Calapan-Batangas and vice versa is applying for Certificate of Public Convenience in the Ministry of Transportation and Communication, Manila;

WHEREAS, if the Certificate of Public Convenience will be granted to the Sto Domingo Shipping lines, there will be a total monopoly of its route and fare of passengers and cargoes as well;

WHEREAS, the riding public will be the victim of this monopoly if Franchise will be granted to Sto Domingo Shipping lines;

NOW, THEREFORE, resolved as it is hereby resolved, to request the Ministry of Transportation and Communication, Metro Manila to disapprove the application of Certificate of Public Convenience of the Sto Domingo Shipping Lines plying Calapan-Batangas and vice versa;
