MUNICIPAL RESOLUTION ESTABLISHING A COMMUNITY DISASTER PREPAREDNESS PROGRAM FOR THE MUNICIPALITY OF BUDALACAO AND CREATING THE BULALACAO DISASTER COORDINATING COUNCIL

WHEREAS, the Philippines has always been subjected to disasters, natural or man-made, all year round;

WHEREAS, the general welfare provisions of the Local Government Code has empowered the Sangguniang Bayan to promote the economic upliftment, social welfare and material progress of the people in the community and insure the protection of their lives and properties;

WHEREAS, Presidential Decree No. 1566 has called for the organization of disaster coordinating councils in all political subdivisions of the government, and planning for disaster operations for all types of emergencies by all national and local government entities;

WHEREAS, Executive Or No. 948 has required the local disaster coordinating councils to maintain a roster of duly accredited Disaster Volunteer Workers (DVWs) for their respective disaster councils as a prerequisite to payment of compensatory benefits;

NOW, THEREFORE, upon motion of Hon. Perpetuo C. Cantos and duly seconded by Hon. Francisco J. Pandino,


BE IT RESOLVED, as it is hereby resolved by this Sangguniang Bayan in session, to authorize the municipal mayor to perform the following acts and deeds, to wit:


1. To organize the Disaster Coordinating Council of Bulalacao, Or. Mindoro; draw up from the local government force and private citizens of the municipality to constitute the Council's membership, and organize special reaction teams to handle specific emergencies in addition to the regular Disaster Coordinating Council task units;
2. To draw up emergency plans for all types of emergencies which may affect the municipality, and
3. To draw up a roster of duly accredited Disaster Volunteer Workers (DVWs) from the residents of the municipality to man the staff and task units of the disaster council.

RESOLVED, FURTHER that copies of this Resolution be furnished to the Chairman, Provincial Disaster Coordinating Council, Calapan, Regional Disaster Coordinating Council through the Office of Civil Defense, Calapan, Or. Mindoro, and the representative of the Ministry of Local Government in the municipality, for their information and guidance.






