" TAX ORDINANCE NO. 15, s. 1993

TAX ORDINANCE AMENDING SECTION 1 OF THE AMENDMENT TO ORDINANCE NO. 3 SERIES OF 1983 BY INCREASING THE FEES IMPOSED UPON OCCUPANTS OF MUNICIPAL STREETS OF BULALACAO, FOR COMMERCIAL PURPOSES, DURING FIESTA OF THIS MUNICIPALITY

" WHEREAS, amendment to Ordinance No. 3, series of 1983 imposed fees upon occupants of municipal streets during fiesta of the Municipality of Bulalacao, Oriental Mindoro who used the said area for selling and shopping purposes;

" WHEREAS, the said imposition is very minimal and need to be increased in order to raise local revenue;

NOW THEREFORE, be it;

RESOLVED as it is HEREBY RESOLVED to amend the Amendment to Ordinance No. 3 series of 1983 and by virtue of the powers vested in the Sangguniang Bayan by Republic Act 7160, the Sangguniang Bayan of Bulalacao, Oriental Mindoro do hereby ordains as follows:

SECTION 1. No person shall be allowed to occupy the designated municipal streets for commercial purposes during the fiesta time of this town without paying the necessary fees enumerated hereunder;

SECTION 2. All operators, proprietors, managers of dry goods stores, eateries, circuses, carnivals, merry-go-rounds, roller coaster, ferries wheel, swings, shooting galleries and other similar establishments shall pay the following fees:

- a) Application Fee - - - - - ₱ 25.00
- b) Mayor's Permit Fee - - - - - 100.00 - 150.00
- c) Medical and Sanitary Fee - - - - - 20.00
- d) Service Fee - - - - - 20.00
- e) Rental Fee - - - - - 50.00 per linear meter

SECTION 3. The fees enumerated above must be paid to, and collected by, the Municipal Treasurer or his duly authorized representatives;

SECTION 4. All occupants who stay beyond February 28 ( 29 in case of leap year) must pay an additional fee of ₱ 25.00 per day;

SECTION 5. Any person found violating any provision of this Tax Ordinance shall be punished by a fine of not exceeding Two Thousand and Five Hundred Pesos (₱2,500.00) or imprisonment of not more than six (6) months or both such fine and imprisonment at the discretion of the Court;

SECTION 6. Ordinance inconsistent hereof are hereby repealed or modified accordingly;

SECTION 7. This Tax Ordinance shall take effect ten (10) days after its publication;

RESOLVED FURTHER, to furnish copies of this Tax Ordinance. the Office of the Municipal Treasurer for their information and implementation;
