REQUESTING HON. RODOLFO G. VALENCIA TO INCLUDE THE CONCRETING OF THE PROVINCIAL ROAD LOCATED AT BULALACAO, ORIENTAL MINDORO AMONG THE DEVELOPMENT PROJECTS OF THE PROVINCE OF ORIENTAL MINDORO FOR CALENDAR YEAR 1994

"WHEREAS, the present condition of the provincial road at this Municipality could easily be classified as bad due to its roughness and so much potholes on it;

"WHEREAS, this condition is an added burden to the travelling public who already has to experience the sorry status of the national highway going to this town;

"WHEREAS, the Local Government Code of 1991 confers to the Provincial Government the responsibility of effective and efficient delivery of basic services and facilities such as infrastructure facilities intended to service the needs of the residents of the province and which are funded out of provincial funds like the provincial roads and other facilities;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED to request Hon. Rodolfo G. Valencia to include the concreting of the provincial road located at Bulalacao, Oriental Mindoro among the Development Projects of the Province of Oriental Mindoro for Calendar Year 1994;

RESOLVED FURTHER, that copies of this resolution be furnished the Provincial Governor for his information and kind consideration, the Provincial Project Development Officer and the Sangguniang Panlalawigan, all of Calapan, Oriental Mindoro for their information and appropriate action.
