" RESOLUTION NO. 93006-051

REQUESTING THE SCHOOLS DIVISION SUPERINTENDENT TO PRIORITIZE THE ELIGIBLE APPLICANTS FROM BULALACAO, ORIENTAL MINDORO IN THE HIRING OF TEACHERS FOR THE SCHOOLS AT THIS MUNICIPALITY

"WHEREAS, public dissatisfaction with education has become chronic and teachers have been at the center of the debates;

"WHEREAS, while the teachers are always the object of criticism, they are looked at as the best hope for reform as their far-reaching influence as agents of constructive change in society beyond question;

"WHEREAS, in the words of Civil Service Commission Chairperson Patricia Sto. Tomas, during the Educators' Convention in Baguio City, this year, the atrocious condition of public schools may be remedied by hiring only those who possess the required teaching skills and when available replace immediately those who are serving in probationary capacity by those who passed the Philippine Board Examination for Teachers;

"WHEREAS, it has been noted that there are several vacancies existing at the schools within this Municipality and apparently there are eligible and qualified graduates from Bulalacao who can handle said vacant teaching positions;

"WHEREAS, it is the considered belief of this body that the young graduates from this Municipality must be given priority in the hiring as a token of appreciation to their parents who persevered in order to send their sons and daughters through college and as a recognition to our young local talents who naturally know the values and share the aspirations of their fellows from Bulalacao;

NOW THEREFORE the SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO for and in consideration of the foregoing premises;

RESOLVED AS IT HEREBY RESOLVES that the Schools Division Superintendent, Department of Education, Culture and Sports, be requested to please prioritize the eligible applicants from Bulalacao, Oriental Mindoro in the hiring of teachers for the schools at this Municipality.




RESOLVED FINALLY, that copies of this resolution be also furnished the District Supervisor, Bulalacao, Central School for his information and reference.


