CONSTRUCTION OF BARANGAY HALL IN POBLACION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Barangay Hall can serve as a venue for both the barangay

tallize issues affecting them and securing proper solutions thereto;

"WHEREAS, the provision of Barangay Hall in Poblacion, Bulalacao,
Oriental Mindoro, would mean a decent and dignified place for barangay
officials to meet and discuss all matters pertinent to the welfare of
their constituents;

"WHEREAS, Bulalacao, Oriental Mindoro is a fifth class municipa-
lity and classified as a PRO-POOR Municipality under Presidential Proc-
lamation No. 390, hence hounds by financial constraints that inhibits
it from constructing barangay hall for each of its fifteen (15) com-
ponent barangays;

eration to the herein request that seeks to give flesh to the noble
ideals of people empowerment;


