" RESOLUTION NO. 008

RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH TO PROVIDE THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WITH ONE (1) UNIT OF AMBULANCE VEHICLE

"WHEREAS, Bulalacao, Oriental Mindoro is populated by twenty-three thousand (23,000) individuals with only one physician attending to them;

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro was among the 159 Low Income Municipalities, in accordance with Executive Order No. 390, dated January 2, 1990;

"WHEREAS, health facilities are too limited due to the absence of hospital and inadequate number of health personnels;

"WHEREAS, the construction of the Community Hospital of this Municipality has been delayed for along time forcing its residents to bring their ailing relatives to the nearest hospital which has a distance of not less than forty (40) kilometers from this town;

"WHEREAS, more than seventy percent (70%) of the residents of this Municipality is living below the poverty line, thus, cannot afford to hire vehicles that will bring the patients to the hospital;

"WHEREAS, it is imperative that the government do something in order to alleviate the present conditions of the citizens who need proper care and medical attention;









NOW THEREFORE:
