RESOLUTION REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, TO INTERVENE IN THE IMMEDIATE CONSTRUCTION OF BULALACAO-MAGSAYSAY-SAN JOSE ROAD

WHEREAS, Bulalacao-Magsaysay-San Jose Road had started the construction last May 1990 but stopped due to unknown reasons;

WHEREAS, according to reliable source there is enough fund for the construction of this project;

WHEREAS, if the above project will be pushed-through at the earliest possible time, this will accelerate the economic and physical development of Bulalacao, aside from the convenience, short travel time that will be rendered to passengers, motorist and the general public specially to Tourist;

WHEREAS, during the visit of President Corazon C. Aquino sometime on April 21, 1991 in San Jose, Occ. Mindoro, she made mentioned that construction of Bulalacao-San Jose National road will be undertaken as early as possible;

NOW, THEREFORE, resolved as is it hereby resolved, to request the Honorable Secretary of the Department of Public Works and Highways, to intervene in the immediate construction and release of fund of Bulalacao-Magsaysay-San Jose road;

RESOLVED, FURTHER, that copies of this Resolution be furnished, the Honorable Madam President Corazon C.
