WHEREAS, re-assessment of real property tax in this municipality as mandated under Section 95 of PD 464 is indispensable;


WHEREAS, in the re-assessment of real property tax one (1) casual employee is needed in the Office of the Municipal Assessor;


NOW, THEREFORE, on motion of Councilor Miguel Villar, duly seconded by all members present; be it;




RESOLVED, FURTHER, that a copy of this resolution be furnished, the Municipal Treasurer, Bulalacao, this Province for his information, guidance and reference;




