RESOLUTION NO. 20

APPROVING THE SUM OF ₱74,651.18 TAKEN FROM THE SURPLUS OF INFRASTRUCTURE FUND CY 1990. TWENTY FIVE THOUSAND PESOS (₱25,000.00) OF WHICH WILL BE USED FOR THE CONSTRUCTION OF THE PUBLIC TOILET AT THE PUBLIC MARKET, CAMPAASAN AND FORTY NINE THOUSAND SIX HUNDRED FIFTY ONE PESOS AND EIGHTEEN CENTAVOS (₱49,651.18) WILL BE USED FOR THE COMPLETION OF THE ANNEX MUNICIPAL BUILDING OF THIS MUNICIPALITY

APPROPRIATING THE SUM OF ₱74,651.18 TAKEN FROM THE SURPLUS OF INFRASTRUCTURE FUND, CY 1990. TWENTY FIVE THOUSAND PESOS (₱25,000.00) WILL BE USED FOR THE CONSTRUCTION OF THE PUBLIC MARKET TOILET AT CAMPAASAN AND FORTY NINE THOUSAND SIX HUNDRED FIFTY ONE PESOS AND EIGHTEEN CENTAVOS WILL BE UTILIZED FOR THE PURCHASE OF MATERIALS FOR COMPLETION OF THE ANNEX MUNICIPAL BUILDING, THIS MUNICIPALITY
