ORDINANCE NO. 93-12-59-A

PENALIZING SLASH AND BURN FARMING, OTHERWISE KNOWN AS KAINGIN SYSTEM, IN THE DECLARED COMMUNAL FOREST OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Any person who makes kaingin for his own private use or for others in the declared communal forest of Bulalacao, Oriental Mindoro shall, upon conviction, be fined in an amount of Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment for six (6) months or both such fine and imprisonment at the discretion of the Court. Provided that conviction on this ordinance shall not bar further prosecution of the offender for violating other pertinent forestry laws such P.D. 705, otherwise known as Revised Forestry Code of the Philippines, while committing violation hereof;

SECTION 2. Ordinances inconsistent hereof are hereby repealed, modified accordingly;

SECTION 3. This ordinance shall take effect ten (10) days after its posting.
