RESOLUTION DECLARING THE 24th DAY OF JUNE AS CLEANLINESS AND COMMUNITY BEAUTIFICATION DAY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, efforts are needed to be undertaken to protect the environmental and ecology, and to assure generations of Filipinos of a balanced ecosystem and a healthy environment;

"WHEREAS, the detrimental effects of pollution on air, water and land have only recently been known and understood, and that recent findings have shown that garbage, industrial or domestic has dire consequences on man and his environment;

"WHEREAS, garbage is indiscriminately dumped on the streets, some are burned, releasing toxic fumes into the air, or dumped into the rivers, shorelines and canals that it needs the focus of much human thought and effort;

"WHEREAS, the wanton disregard of proper waste disposal could lead to the introduction and spread of diseases;

"WHEREAS, as our municipality has eleven (11) areas declared under Presidential Proclamation 1801 as tourist spot reserves, protection and further beautification of our town need to be done;

"WHEREAS, given all the realities, revival, reaffirmation and involvement of the age-old Filipino tradition and custom of " bayanihan ", " kalinisan " and " pakikisama " will guide us, as we try to solved our environmental problems within the rubric of environmentally sound and sustainable development;

NOW THEREFORE, for and in consideration of the foregoing premises be it RESOLVED by the Sangguniang Bayan of Bulalacao, riental Mindoro as it HEREBY RESOLVES that the 24th day of June be declare/as " Cleanliness and Community Beautification Day of Bulalacao, riental Mindoro;

RESOLVED FURTHER; that copies of this resolution be furnished all government agencies, national and local, Association of Barangay Captains, Municipal Bederation of the Sangguniang Kabataan and the accredited non-governmental and people's organizations, all of Bulalacao, riental Mindoro for their information and guidance.
