EARNESTLY REQUESTING THE REGIONAL DIRECTOR, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, REGION IV-B TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF A FISH PORT AT BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro is one part in our country that needs infrastructure support to handle fish catch in order to maximize the harvest that it gets out of its coastal area;

"WHEREAS, there is a need to reduce post harvest losses, improve the quality of produce for domestic and export consumers, enhance monetary returns of small-scale fishermen and to promote efficient packing and processing produce, hence, the necessity to construct a municipal fishing port on this Municipality which is traditional fish collection center and transshipment point to urban markets;


