EARNESTLY REQUESTING THE ADMINISTRATOR, NATIONAL IRRIGATION ADMINISTRATION TO DEVELOP THE IRRIGATION SYSTEM AT BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is one among 15 municipalities of Oriental Mindoro with a total land area of 305,100 hectares whose major source of income of the residents is agriculture (farming);

"WHEREAS, only 8% of the area is fully utilized in the production; hence, the municipality suffers a big deficit in terms of total annual consumption vis-'a-vis its total annual production;

"WHEREAS, one of the factors that aggravates the problem, aside from the inadequacy of technical knowledge on the part of the farmers and high cost of production, is the absence of infrastructural support facilities;


"WHEREAS, in the face of worsening rice crisis the nation is experiencing, efforts and resources need to be concentrated on mechanism and facilities which could help increase the production of this staple crop; Now; therefore, be it
