REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR, TO CAUSE THE IMMEDIATE COMPLETION AND SUBSEQUENT OPERATION OF BULALACAO MUNICIPAL HOSPITAL

"WHEREAS, it is the strong clamor and an oft-repeated request by this sanggunian from concerned government official to complete the construction of the Ten-Bed Bulalacao Municipal Hospital;

"WHEREAS, cognizant of the evident health problems suffered by the inhabitants of this Municipality, the Provincial Government, through Governor Valencia, coordinated with the Commission on Audit (COA) to conduct an investigation and evaluation of the project to determine the cause for the abandonment of the subject unfinished hospital;

"WHEREAS, upon investigation thereof, COA records revealed that the project has an unexpended balance of ₱ 1,129,853.33 including the 10% retention deducted from every progress payments amounting to ₱320,736.00 which would be readily available if the Provincial Government opted to complete the construction of the said hospital;

"WHEREAS, apparently, Governor Valencia is highly desirous of seeing the construction of the subject hospital finished pending however for the result and recommendation by the COA;


