" RESOLUTION NO. 95-09-060

RECOMMENDING TO THE MUNICIPAL MAYOR THE CHANGE OF STATUS
OF NELSON S. BANTUGAN, MUNICIPAL ENGINEER, FROM TEMPORARY
TO PERMANENT

"WHEREAS, Nelson S. Bantugan was appointed as Municipal Engineer under a Temporary status on January 9, 1995;

"WHEREAS, the only qualifying requirements which Mr. Bantugan failed to meet in order to get permanent appointment was the insufficiency of work experience;

"WHEREAS, on July 9, 1995, subject appointee has satisfied the six (6) month lacking experience specifically mentioned in the notation by Civil Service Commission appearing at the back of appointment paper issued to him on January 9, 1995;

"WHEREAS, it is provided under Section 477 par (a) of Republic Act Numbered 7160, also known as the Local Government Code of 1991, that among the qualifications for the position of Municipal Engineer is that he must be a resident of the local government unit concerned;

"WHEREAS, at present, there is an absence of actually available qualified applicant to the position of Municipal Engineer aside from Mr. Bantugan;

"WHEREAS, it is imperative for this Municipality to have a permanent Municipal Engineer to undertake the important duties of advising the Mayor and this Sanggunian on matters involving infrastructures and public works functions as well as the actual implementation related to which he must administer, coordinate, supervise and control;


"WHEREAS, it shall be practical, beneficial and to the best interest of the public service if the person in-charge of an office vested with very important duties such as the Office of the Municipal Engineer is of permanent capacity, thereby attaining consistency in the quality of service and getting more diligence and sense of responsibility on the part of the employee; Now therefore, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, To respectfully recommend to the Municipal Mayor the change of status of Nelson S. Bantugan, Municipal Engineer, having met all the requirements for the position to which he is appointed including the appropriate eligibility prescribed in accordance with the provision of law, rules and standards promulgated in pursuant thereof, from Temporary to Permanent;






