RESOLUTION CONCURRING THE APPOINTMENT OF ROMEO O. FALLARIA AS MUNICIPAL ACCOUNTANT UNDER PERMANENT STATUS IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO
