EARNESTLY REQUESTING HIS EXCELLENCY, JOSEPH EJERCITO ESTRADA, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS FOR THE ESTABLISHMENT OF THE BIGASANG BAYAN OF THE SENIOR CITIZENS FEDERATION IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Senior Citizens Federation of the Municipality of Bulalacao, Province of Oriental Mindoro wishes to establish a Bigasang Bayan to facilitate the sufficient supply of rice at an affordable price to its members during rainy season where rice hoarding is rampant;

"WHEREAS, it is believed that the establishment of the Bigasang Bayan for the Senior Citizens would ease the burden of the elderly who because of poverty could hardly cope up with their basic needs for daily sustenance;

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro being a Pro-Poor Municipality with limited funds finds it difficult to augment the previous allocation for the senior citizens that the assistance of the benevolent president is direly needed; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request His Excellency, Joseph Ejercito Estrada, President, Republic of the Philippines to allocate funds for the establishment of the Bigasang Bayan of the Senior Citizens Federation in the Municipality of Bulalacao, Province of Oriental Mindoro;
