## RESOLUTION NO. 11-04-073

**EARNESTLY REQUESTING HIS EXCELLENCY JEJOMAR C. BINAY, VICE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND CHAIRMAN, SOCIALIZED HOUSING FINANCE CORPORATION TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE MILLION PESOS (PHP5M) FOR THE PURCHASE OF RESIDENTIAL LOTS FOR THE POOR AND LANDLESS RESIDENTS OF SITIO TABUK, BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO**

**"WHEREAS,** Section 19 of Republic Act Numbered 7160 otherwise known as the Local Government Code of 1991 provides that a local government unit may, through its chief executive and acting pursuant to an ordinance, the power of eminent domain for public use, or purpose, or welfare for the benefit of the poor and the landless upon payment of just compensation, pursuant to the provisions of the Constitution and pertinent laws;

**"WHEREAS,** it is interesting to note that under the abovestated provision eminent domain may be resorted to for public welfare, for the benefit specifically of the poor and the landless thereby rendering special attention to those living under the economic threshold;

**"WHEREAS,** it is the strong clamor of the residents of Sitio Tabuk, Poblacion, Bulalacao, Oriental Mindoro, comprised of 215 households with an approximate 1,000 number of inhabitants occupying the residential land belonging to a certain Leonides Sotero JA. Kalagayan;

"WHEREAS, faced with the financial burden for the payment of just compensation to the owner of the occupied land, this Sanggunian humbly appeals to the generosity and heart for the poor of Vice President Jejomar "Jojo" Binay who now concurrently serves as Chairman of the Socialized Housing Finance Corporation;

"WHEREAS, we believe and support the goal, thrust and initiative of the good Vice President to uplift the living condition of the underprivilege Filipinos by providing access to affordable shelter financing; working in partnership with multi-sectoral stakeholders for the development and implementation of innovative and sustainable social housing program; Now, therefore, be it


**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request His Excellency Jejomar C. Binay, Vice President of the Republic of the Philippines and Chairman, Socialized Housing Finance Corporation to extend financial assistance in the amount of Five Million Pesos (Php5M) for the purchase of residential lots for the poor and landless residents of Sitio Tabuk, Barangay Poblacion, Bulalacao, Oriental Mindoro;






