" RESOLUTION NO. 00-04-072

EARNESTLY REQUESTING THE HONORABLE GREGORIO B. HONASAN, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE PURCHASE OF 12 UNITS HANDSET RADIO, CAMERA AND TELESCOPE TO BE USED BY THE FISH WARDEN OF EIGHT COASTAL BARANGAYS AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, in an effort to arrest the problem on illegal fishing, the Municipality of Bulalacao organized the Municipal Fisheries and Aquatic Resource Management Council (FARMC) comprising its eight coastal barangays and designating fish wardens for each barangay;


"WHEREAS, various support and assistance has been provided to the fish warden to make them effective and efficient in the performance of their duties such as the patrol boat to be used in the conduct of a daily seaborne patrol;

"WHEREAS, in addition to the patrol boat, there is a dire need to provide the fish warden with the necessary paraphernalia such as 12 units handset radio, camera and telescope which are very important in monitoring, surveillance and apprehension of the violators; Now, therefore, be it


