EARNESTLY REQUESTING THE HONORABLE ALFONSO V. UMALI,  
CONGRESSMAN, 1<sup>ST</sup> DISTRICT, ORIENTAL MINDORO TO FACILITATE THE  
IMMEDIATE CLASSIFICATION OF BULALACAO-MAGSAYSAY  
CIRCUMFERENTIAL ROAD INTO A NATIONAL HIGHWAY

"WHEREAS, there is a newly constructed road traversing the Municipalities of Bulalacao, Oriental Mindoro and Magsaysay, Occidental Mindoro designed to serve the inhabitants of the two provinces connected by such road in their intertwining interests and benefits however, the classification of that road is not expressly defined,

"WHEREAS, noting that financial constraint on the part of the Local Government Units it is still critical for them to undertake the delivery of infrastructural services such that those deal with maintenance and operation of roads and bridges, it is important therefor to clarify the matter of classifying the abovementioned road with a national highway in order to ensure the safety of such infrastructure facility the highest efficiency and the most appropriate quality in construction and ensure that actual construction is done in accordance with government plans and specifications,

"WHEREAS, the convention or classification of such road into a national highway category shall definitely redound to financial and socio-economic well-being of the local government units concerned for it could entail lesser funding from the LGU's which they hardly could afford to;

"WHEREAS, while there are greater benefits in expanding the devolution of powers from DPWH in favor of the LGU's as suggested by the former Secretary estowar in order to advance the cause of local autonomy it is but practical to view the subject on its proper prospective that is the financial capability of local government concerned,


WHEREAS, to promote the general welfare of the localities concerned subject to the limitations set by the Constitution and their financial capabilities it is imperative that the said road be classified as the national highway, Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED,** To: Earnestly request the Honorable Alfonso V. Umali, Congressman, 2<sup>nd</sup> District, Oriental Mindoro to facilitate the immediate classification of Bulalacao-Magsaysay Circumferential Road into a National Highway;
