RESOLUTION NO. 01-07-093

REQUESTING THE HONORABLE BARTOLOME L. MARASIGAN, PROVINCIAL GOVERNOR, PROVINCE OF ORIENTAL MINDORO TO CONDUCT INVESTIGATION ON THE ALLEGED ILLEGAL RELEASE OF FUNDS FROM THE PILIPINAS SHELL FOUNDATION, INC. OR MALAMPAYA GAS PROJECT INTENDED FOR THE LIVELIHOOD PROGRAMS OF BARANGAY BALATASAN, MUNICIPALITY OF BULALACAO, THIS PROVINCE

"WHEREAS, the discovery of the natural gas reserves in Palawan by the Shell Philippines Exploration caused the construction and operation of an offshore pipelines off the coast of the Province of Oriental Mindoro more particularly at the Municipality of Bulalacao;

"WHEREAS, in view of the implementation of project, the Shell Philippines Exploration allocated the amount of One Million US Dollars (US \$1,000,000.00) to finance the sustainable development projects for Oriental Mindoro in partnership with the Province and shall be likewise distributed to different Municipalities affected by the laying of pipelines such as that of the Municipality of Bulalacao through the Integrated Development Program for Fishermen (IDPF);

"WHEREAS, in order to benefit the financial assistance from the Shell Philippines Exploration through livelihood programs, the Municipality of Bulalacao comprehensively prepared the IDPF in accordance with the priority of the eight (8) coastal barangays affected by the Malampaya Gas pipelines;


