RESOLUTION REPEALING RESOLUTION NO. 99-11-236 ENTITLED "REQUESTING THE CENRO TO STOP ISSUING PERMITS TO CHARCOAL MANUFACTURERS, DEALERS AND OTHERS WITHIN THE AREA OF JURISDICTION OF BULALACAO"

"WHEREAS, the Community Environment and Natural Resources Office is tasked to issue permits allowing charcoal production;


"WHEREAS, there was the Sangguniang Resolution No. 99-11-236 entitled "Requesting the CENRO to stop issuing permits to charcoal manufacturers, dealers and others within the area of jurisdiction of Bulalacao";


"WHEREAS, such regulation must be balanced vis a vis local employment by poor residents for having responsibility of planting ipil-ipil trees for charcoal production; thus, it is considered prudent that the legitimate producers be allowed to pursue their means of living; Now, therefore, be it


