EARNESTLY REQUESTING THE HONORABLE EDGARDO J. ANGARA, SECRETARY, DEPARTMENT OF AGRICULTURE TO ALLOCATE THE NECESSARY FUNDS FOR THE REHABILITATION OF FARM TO MARKET ROAD FROM SITIO DANGCALAN-LIBTONG TO BARANGAY SAN ROQUE AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is happy to know that the present thrust of the Erap Administration includes the repair and construction of farm to market roads;

"WHEREAS, Dangcalan-Libtong to Barangay San Roque farm to market road is difficult to pass even during summer season and becomes muddy and slippery during rainy season which delayed the transportation of various agricultural products of that barangay to the detriment of the socioeconomic development of this Municipality as a whole;

"WHEREAS, in addition to the above, the rehabilitation of the mentioned road would ease both the teachers and pupils of San Roque Elementary School who are traversing on the same road everyday;


