"WHEREAS, the hanging bridge mentioned above which is temporarily built needs further improvement and at least be maintained to ensure the safety of the residents living therein;


"WHEREAS, the maintenance of the abovementioned hanging bridge shall definitely redound to the socio-economic benefits of the people living therein; Now, therefore, be it


