EARNESTLY REQUESTING THE HONORABLE LUIS LORENZO, SECRETARY, DEPARTMENT OF AGRICULTURE TO DEVOLVE TO THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO THE MANAGEMENT AND CONTROL OF THE 96 HECTARES FISHPOND LEASE AGREEMENT SITUATED AT SITIO TABOK, BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the 96 hectares of the Fishpond Lease Agreement (FLA) situated at Sitio Tabok, Barangay Poblacion, Bulalacao, Oriental Mindoro which was previously granted to Mr. Arnulfo Sison was cancelled by the Bureau of Fisheries and Aquatic Resources (BFAR) due to his failure to develop the area;


"WHEREAS, since the cancellation of the FLA, encroachment have been made by some people without securing any permit from the Municipal Government of Bulalacao or from BFAR, this situation leads to misunderstanding and dispute among the occupants and even brought problems to the LGU which could not immediately act on it for respect to the concerned higher government agencies who still have direct supervision on that Fishpond Lease Agreement;


"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro is presently formulating developmental projects which shall be implemented in that area if all the rights, management and control be granted to the former by the higher government agencies such as that of BFAR and the Department of Agriculture; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Honorable Luis Lorenzo, Secretary, Department of Agriculture to devolve to the Local Government Unit of Bulalacao, Oriental Mindoro the management and control of the 96 hectares Fishpond Lease Agreement situated at Sitio Tabok, Barangay Poblacion, Bulalacao, Oriental Mindoro;


