RESOLVED, to approved the following Ordinance:

ORDINANCE NO. 11

ORDINANCE NO

REQUIRING PERSONS, ASSOCIATIONS, COMPANIES AND CORPORATIONS TO SECURE PERMIT FROM THE OFFICE OF THE MAYOR BEFORE DRYING, RICE, CORN, COPRA AND ETC. INSIDE THE BASKET BALL COURT OF POBLACION, BULALACAO, ORIENTAL MINDORO

WHEREAS, the basket ball court of this town is not only use for playing basket ball but it is also use for drying rice, corn, copra, and other purposes;

WHEREAS, it is worthwhile that persons using the basket ball court for the purpose above-mentioned should secure permit from the Mayor and shall pay corresponding rentals to the Municipal Treasurer for using the same;

WHEREAS, to regulate the paying of rentals of the basket ball court, the Sangguniang Bayan of Bulalacao, hereby Ordains that:

Section 1.- All persons, corporations, associations and companies before using the hard court of Poblacion, this Municipality for drying corn, rice, copra and etc., are hereby required to secure permit from the Office of the Municipal Mayor and shall pay to the Municipal Treasurer the amount of ₱0.25 per sack or bayeng of rice, corn and copra as rentals thereof;

Section 2.- Persons, Corporations, Associations and Companies are hereby allowed only to dry, rice, copra and corn inside the basket ball if there is no schedule of games to be played thereat. And no basket ball games shall be held without securing permit from the Office of the Mayor to avoid conflict of the drying of the above-mentioned products and basket ball games to be played. Provided, however, if the court is use by corporation, companies, Associations and private persons for showing movies and pre-pagandas, without collecting fees from the public, no rentals shall be charged to the same thereof;

Section 3.- Violation of this Ordinance or parts thereof shall be fined the amount of ₱50.00 to ₱200.00 and an imprisonment of 15 days to 30 days or both such fine and imprisonment at the discretion of the court.

Section 4.- Ordinances or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 5.- This Ordinance shall take effect Ten days after its passage.
