The meeting was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also by the Recorder and there no objection so on motion of Hon. Modesto O. Bacawag, seconded by Hon. Ulpiano C. Pandino, the minutes stands as confirmed.

Three draft resolutions, namely: Resolution requesting the Minister, Ministry of Natural Resources, Quezon City to reserve the 52 lots under Cadastral Survey, PLS- 395-D, series of 1952 at Sitio Lampuyang, Nasucob, Bulalacao, Oriental Mindoro for planting Ipil-ipil, buri, bamboo and other trees suitable for reforestation, Resolution requesting the Minister, Ministry of Natural Resources to include in the Reforestation Program, the reforestation of the Communal Forest of this town and Resolution requesting His Excellency President Ferdinand S. Marcos to do favor in the incashing of Postal Money Order, were read for approval.

The meeting was suspended at 10:30 AM to entertain Mr. Eduardo C. Aceron, Municipal Development Coordinator. Aceron explained in detail the functions of the KKK. He said the suggestion should come from the Municipal Development Council for recommendation to the higher Office. At this juncture Hon. Wilfredo Embile alleged that one of the best projects for recommendation is goat raising. Aside from this, goats produces rapidly and many people will be given the privilege to join this program. While cow fattening is expensive and few people could join the program.

The Presiding Officer has set aside the proposed projects for feasibility study of the Office concern.

The representatives from the Rural Health Center of this town in the persons of Dr. Sonny Absalon and Mrs. Angeles Villar, Midwife, appeared personally to present their problems. One of the problems they presented is the forthcoming Seminar to be undertaken in connection with the Botica ng Barangay. They said the Seminar will not prosper unless the Municipal government will give financial aid for the expenses.

RESOLUTION NO. 57

The Sangguniang Bayan of Bulalacao, on motion of Hon. Wilfredo F. Embile, seconded by Hon. Francisco J. Pandino, resolved, to approved the following Ordinance:

ORDINANCE NO. 10 ✓

ORDINANCE NO.

REQUIRING PERSON/PERSONS TO PAY PERMIT FEES, CEMETERY RENTALS, SERVICE FEES, FEES ON MARRIAGE SOLEMNIZE OUTSIDE THE OFFICE OF THE MAYOR, ISSUANCE OF BIRTH CERTIFICATES, BRANDING OF LARGE CATTLE OUTSIDE THE MUNICIPAL COMPOUND AND PROVIDING FINES AND PUNISHMENTS FOR EVERY VIOLATION THEREOF.

Be it Ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in Session Assembled.

Section 1.- There shall be paid to the Municipal Treasurer for every permit issued by the Municipal Mayor on the following:

- A.- Marriage Solemnize outside the Office of the Mayor - ₱10.00 P.Sol.
- B.- Issuance of Birth Certificate - - - - - 10.00 p.child
- C. Service Fee on large cattles branded outside the Municipal Compound - - - - - 2.00 p. h.
- D.- CEMETERY RENTALS:
 - 1. Children - - - - - 5.00 p. b.
 - 2. Adult - - - - - 10.00 p. b.
 - 3. Exhumation of Cadaver - - - - - 10.00 p.per.
 - 4. Removal of Cadaver - - - - - 10.00 "
 - 5. Transfer of Cadaver to other places outside the Municipality - - - - - 50.00 "
 - 6. Construction of Nitch (Pantalon) - - - - - 20.00 "

Provided, however, effective January, 1982 all rentals for 5 years and to be removed for 5 years must be surveyed to determine the rentals to be paid. Provided further, if the owner of the dead is outside jurisdiction, the same must be notified of the removal of the remains. Provided, further more, if he fails to remove the remains of the dead person, he will be required to pay another rentals for five years, if he fails to pay the rentals provided for, it is up for the Municipal government to decide on the matter.

Section 2.- Violation of this Ordinance or parts thereof, shall be fined the amount of ₱50.00 to ₱200.00 and an imprisonment of 15 days to 30 days or both such fine and imprisonment at the discretion of the Court.

Section 3.- Ordinance or Ordinances inconsistent with the Provisions of this Ordinance are hereby repealed or modified accordingly.


Section 4.- This Ordinance shall take effect immediately upon its approval.


