RESOLUTION NO. 1

The Sangguniang Bayan of Bulalacao, on the motion of Hon. Lazaro P. Vizconde, seconded by Hon. Ulpiano C. Pandino,

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 1

ORDINANCE NO.

AMENDING ORDINANCE NO. 10, S. of 1979 AND FIXING THE RATE OF WATER SERVICE FEES AND REGULATING THE CONNECTION OF WATER PIPES IN BOBLACION, BULALACAO ORIENTAL MINDORO.

WHEREAS, it has been observed that many people in Poblacion having faucet are neglecting to pay their water service fee,

WHEREAS, in order to maintain and regulate the collection of water service fees and the connection of water pipes in this town, the Sangguniang Bayan hereby ordains, that;

SECTION 1- A monthly water service fees of ₱5.00 will be charged to person or persons having one(1) or two (2) faucets connected by the Municipal Government to their respective houses.

SECTION 2- If a person will connect to his house another additional faucet aside from the two faucets allowed and mentioned in Section 1 hereof he shall pay an additional monthly Fee of ₱2.00 for every faucet connected thereat.

SECTION 3- A person who neglects to pay his monthly water service fees or allow often times the continuous flow of water in his faucet, a warning will be given either by letter or personal contact. Then if the same act will be committed by the same for the second time, the pipe will be cut or closed with plugs.


SECTION 4- If the pipe or faucet are destroyed and need repairs the owner of the same will be given a duration of 3 days to repair the damage. If he fails again to repair the pipes and the faucet within the prescribed period, the pipes will be also be cut or closed with plugs.

SECTION 5- Violation of this Ordinance or part thereof, shall be fined the amount of ₱50.00 to ₱200.00 or an imprisonment of 10 days to 30 days or both such fine and imprisonment at the discretion of the Court.

SECTION 6- Previous Ordinance or Ordinances in consistent with the Provision of this Ordinance, except the installation Fees and Mayor's Permit to connect water pipes, are hereby repealed or modified accordingly.

SECTION 7- This Ordinance shall take effect immediately upon its approval .... UNANIMOUSLY APPROVED.
