RESOLUTION NO. 58 ✓

REQUESTING THE PROVINCIAL COMMANDER, CALAPAN, ORIENTAL MINDORO TO
RETAIN P/SGT EDISON ATIENZA AS STATION COMMANDER, BULALACAO, ORIENTAL
MINDORO

WHEREAS, this Honorable body, the Sangguniang Bayan of Bulalacao
was informed that P/Sgt Edison Atienza will be transferred to other
stations

WHEREAS, because of the transfer of P/Sgt Edison Atienza, the town of Bulalacao will miss a soldier whose service was dedicated unselfishly to the people;

WHEREAS, from the time of his assignment as Station Commander of this Municipality P/Sgt Edison Atienza made several accomplishments enumerated as follows to wit:

a. Recovery of four stolen carabao at Calintaan, San Jose, Occ. Mindoro thru constant follow-up on March 1982;

b. Recovery of stolen properties worth ₱19,000.00 at San Jose, Occ. Mindoro, which were taken from the house of Leonides Kalagayan at Tabok, Poblacion this Municipality on March 1982;

c. Solution of the thievery case and recovery of stolen eleven cows at San Vicente, Romas this province through joint operations with the Mansalay and Romas Police Stations on March 1982;

d. Confiscation of marijuana plants from Bendios Genisa inside his house at Riverside, Poblacion this Municipality on August 1982 after a week-long covert surveillance;

e. Recovery of three stolen cows along the mountain ranges of Gundayan, Mansalay this province on August 1982 and apprehension of one of the suspects and successful filing of the case in court;

f. Successful encounter against a group of armed men on board a motorized banca along Tabok River on 282100H February 1982 resulting to dog-chasing up to Alibog, San Jose, Occ. Mindoro, where two of the groups were apprehended, confiscation of two firearms, two handgrenades and a motorized banca;

g. Constant seaborne patrolling within the seawater of the jurisdiction of Bulalacao have fully minimized the operations of illegal fishing which was reported to be severely rampant during the past days;

NOW THEREFORE, resolved, as it is hereby resolved to request the Provincial Commander, Calapan, Oriental Mindoro to retain P/Sgt Edison Atienza as Station Commander of Bulalacao, Oriental Mindoro;

RESOLVED, FURTHER, that copies of this Resolution be furnished the Provincial Commander, PG Headquarters, Calapan, Oriental Mindoro for consideration and P/Sgt Edison Atienza for his information and guidance.

UNANIMOUSLY APPROVED.

There being no other business to be transacted so on motion of Hon. Modesto G. Baccweg, seconded by Hon. Perpetuo C. Santos, the session was adjourned at 12:00 AM....
