RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 8

DECLARING THE 4TH DAY AFTER THE TOWN FIESTA OF BULALACAO, ORIENTAL MINDORO,
WHICH IS CELEBRATED ON THE FIRST FRIDAY, SATURDAY AND SUNDAY OF THE MONTH
OF FEBRUARY OF EACH CALENDAR YEAR, AS HOLIDAY

WHEREAS, the town fiesta of Bulalacao, Oriental Mindoro falls on the
first Friday, Saturday and Sunday of the month of February of each Calendar
year;

WHEREAS, because of the three successive days and nights fiesta, Municipal and National employees who were incharged of the preparation of same are tired, sleepy and exhausted;

WHEREAS, the 4th day after the town fiesta of Dulalacao falls on Monday and in view hereof, the Sangguniang Bayan hereby Ordains, that:

SECTION 1. The fourth day after the town fiesta of Dulalacao which falls on Monday of the first week of the month of February of each calendar year is hereby declared Holiday by the Sangguniang Bayan;

SECTION 2. Municipal and National employees shall observe the fourth day after the town fiesta of Dulalacao as rest day and the same may or may not attend office hours or classes;











SECTION 3. Previous Municipal Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;
