The session was called to order at 9:30 o'clock in the morning with Hon. Ulpiano C. Pandino as the Temporary Presiding Officer.

The calling of the roll was performed by the Secretary with the members answering present when their respective names were called.

The previous minutes was also read and there is objection by Hon. Wilfredo F. Embile to the Ordinance expelling students in the Bulalacao Municipal High School, attending classes here under the influence of liquor. Hon. Wilfredo F. Embile made his strong objection to the Ordinance because this is in conflict with the MEC rules and regulations.

The MEC order relative to the exemption of students of Barangay Officials was read for comment. The Presiding Officer said the Municipal government cannot shoulder the tuition fees of the forty students in the Bulalacao Municipal High School due to lack of funds, if the Bulalacao Municipal High School will be nationalized then these students will be exempted from paying their tuition fees, the Presiding officer, added.

The Secretary was instructed by this Honorable body to indorse the letter of the Barangay Council of San Roque to Mayor Bago for proper action.. UNANIMOUSLY APPROVED.

The Secretary is likewise instructed to send a letter to SP member, Edgardo Acaron, requesting him to do something with the donation or right of way of the construction of Poblacion-San Miguel Barangay road.

INFORMING THE NATIONAL IRRIGATION ADMINISTRATION, CALAPAN, ORIENTAL MINDORO THAT THE WATER OF CABILIAN COMMONAL IRRIGATION PROJECT (CCIP) STARTING FROM THE BARANGAY OF NASUCOB UP TO GAMBUNANG, THIS MUNICIPALITY IS NOT FLOWING OR FUNCTIONING

WHEREAS, this Honorable body, the Sangguniang Bayan of Bulalacao was informed that the Cabilian Commonal Irrigation Project (CCIP) has been reported finished and hundreds of hectares in the barangays of Nasucob and Gambunang were being supplied with water;

WHEREAS, there are also confirmed reports from the people in these two barangays that the water of the Cabilian Commonal Irrigation Project (CCIP) starting from the barangay of Nasucob up to Cambunang is not flowing;

NOW THEREFORE, resolved as it is hereby resolved to inform the National Irrigation Administration (NIA) - S, Calapan, Oriental Mindoro that the water of the Cabilian Commonal Irrigation Project (CCIP) starting from the barangay of Nasucob, to Cambunang, despite being reported finished or completed, yet it is not flowing or functioning;

RESOLVED, FURTHER, that copy of this Resolution be furnished the National Irrigation Administration (NIA) - S, Calapan, Oriental Mindoro and the NIA Office, Manila for their information and guidance...
