RESOLUTION NO. 57 ✓

REQUESTING THE SANGGUNIANG PANLALAWIGAN, CALAPAN, ORIENTAL MINDORO TO SHOULDER THE AMOUNT OF ₱100,000.00 FOR ELECTRIFICATION FROM THE MUNICIPALITY OF MANSALAY TO THE MUNICIPALITY OF BULALACAO

WHEREAS, this Honorable body was informed that ORMEGO II needs ₱100,000.00 for the completion of Electrification from the municipality of Mansalay to the municipality of Bulalacao;

WHEREAS, the Provincial government of Oriental Mindoro has given aid in the amount of ₱30,000.00 to the municipality of Bulalacao for said electrification;

WHEREAS, this Honorable body was also informed that there was a proposal that the amount of ₱70,000.00 should be equally contributed by the 15 municipalities of Oriental Mindoro and to be paid by the municipality of Bulalacao from the collection of electric bills;

WHEREAS, this proposal sounds good but there is a controversial of contribution among the 15 municipalities especially that these municipalities had already appropriated and approved their respective Municipal Annual Budgets for their projects;

NOW, THEREFORE, resolved as it is hereby resolved, to request the Sangguniang Panlalawigan, this Province to shoulder the amount of ₱100,000.00 for the completion of electrification of this municipality and that the municipal government of Bulalacao will pay to the Provincial Government said amount from the collection of electric bills;

RESOLVED, FURTHER, that if the Provincial government will not shoulder the amount aforesaid, for electrification, then it is most respectfully requested that the amount of ₱30,000.00 be granted to the municipality of Bulalacao for the cementing of Municipal streets;

RESOLVED, FURTHERMORE, that copies of this resolution be furnished, the Sangguniang Panlalawigan, Calapan, Oriental Mindoro for consideration..
