RESOLUTION NO. 46

RESOLUTION REQUESTING THE BUREAU OF FOREST DEVELOPMENT TO RETAIN JURISDICTION
OVER A PARCEL OF FOREST LAND COVERED BY PROCLAMATION 2282 AND TO THE MINISTRY
OF HUMAN SETTLEMENTS TO WAIVE JURISDICTION OVER SAID AREA IN FAVOR OF THE BU-
REAU OF FOREST DEVELOPMENT

WHEREAS, the Sangguniang Bayan of Bulalacao is very much concerned and
committed to assist the Hanunuo Mangayaa residing in the municipality of Bu-
lalacao;

WHEREAS, we recognized the existence of Fundasyon Hanunuo Mangyan, a pri-
vate foundation duly registered with the Securities and Exchange Commission
and accredited as a peasant's Tribal Association by the Bureau of Rural Wor-
kers, Ministry of Labor and Employment with principal Office at Bailan, Bula-
lacao, Oriental Mindoro;

WHEREAS, the foundation has applied for a communal Forest Lease covering
3,980 hectares in the Sitios of Umabang, Bailan, all in Bulalacao, Oriental
Mindoro on December 20, 1981;

WHEREAS, such application comprises the Ancestral lands of the said Hanu-
nuo where they have lived and toiled continuously by succession since time im-
memorial;

WHEREAS, while such application was pending before the Bureau of Forest
Development in abeyance of guidelines for the issuance of CFL Proclamation 2282
was promulgated in March 29, 1983;


WHEREAS, Proclamation 2282 recognizes prior rights to the land concessions
that land to which prior rights have been established will be excluded from
the separation of such proclamation;

RESOLVED, as it is hereby resolved, that in recognition of their Ance-
stral Land rights and in our desire to have land granted to bonafide occupants
the area be excluded from Proclamation 2282 and that the Ministry of Human
Settlements waive jurisdiction over the area in favor of the Bureau of Forest
Development. That the area be declared by the Bureau of Forest Development as
an Integrated Social Forest Area and the Fundasyon Hanunuo Mangayan Communal
Forest Lease be favorably considered.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Bureau
of Forest Development, Visayas Avenue, Diliman, Quezon City for their appropriate
action.

On motion by Hon. Jose P. Paigao, seconded by Hon. Francisco J. Pandino, this resolution was... UNANIMOUSLY APPROVED.
