LACAO, ORIENTAL MINDORO

WHEREAS, the municipality of Bulalacao is located in the Southernmost
of the Province of Oriental Mindoro;

WHEREAS, this town has no government Physician nor Private practitioner
for nine (9) years to safeguard the lives of the 16,942 inhabitants;

WHEREAS, the nearest hospital to this town is Roxas General Hospital,
Roxas, Oriental Mindoro with a distance of 46 kilometers;

WHEREAS, poor and indigent patients who cannot afford to hire vehicles
in going to Roxas General Hospital passed away without being examine by a
Doctor;

WHEREAS, resolutions requesting for the assignment of Physician in this
municipality were sent to the Ministry of Health, Manila but no Physician was
assigned;

WHEREAS, this Honorable body was officially informed that a Lady Physician
in the name of Dra. Genera D. Retuita who was formerly assigned at the PANAMIN
in Sitio Dangkalán, Bulalacao is waiting for her re-assignment;


WHEREAS, if Dra. Genera D. Retuita could not be assigned in the PANAMIN,
the Sangguniang Bayan hereby agree and accept her assignment in this town;

sideration.


