WHEREAS, the Sangguniang Bayan of Bulalacao on its Regular session held on February 6, 1985, has received a report that Mayor Dolores S. Bago had resigned from the KBL party;

WHEREAS, Municipal and Barangay officials of this town who belong to the KBL were not consulted before the resignation of Mayor Bago was done;

WHEREAS, Mayor Dolores S. Bago had been in the Majority party for eighteen years, four years as Vice Mayor, and sixteen years as Municipal Mayor and the same has never been defeated in politics;

WHEREAS, the Sangguniang Bayan believes that the resignation of Mayor Bago might have been influenced by outside persons just to paralyze or weaken the strenght of the KBL in this municipality;


NOW, THEREFORE, on motion by Hon. Wilfredo F. Embile, seconded by Hon. Ulpiano C. Pandino, be it;

RESOLVED, FURTHER, that copies of this resolution be furnished the Secretary General Kilusang Bagong Lipunan, Metro Manila, for consideration;


UNANIMOUSLY APPROVED




