RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 3

REQUIRING MOTORCYCLE AND BICYCLE OPERATORS/OWNERS TO PAY MAYOR'S PERMIT BEFORE  
OPERATING OR USING THE SAME IN THIS MUNICIPALITY

WHEREAS, sooner or later this municipality shall become progressive;

WHEREAS, when this town is in progress, transportation facilities like  
motorcycle and bicycle, aside from Buses and jeepneys will be also needed;

WHEREAS, since motorcycle and bicycle will be also needed by people in  
this Municipality, the Sangguniang Bayan hereby Ordains, that:

SECTION I. All motorcycle and Bicycle owners are hereby required to pay  
Mayor's Permit before operating or using it in this Municipality, to wit:

- a) Motorcycle . . . . . ₱50.00
- b) Bicycle . . . . . 25.00

SECTION 2. No motorcycle and bicycle shall be used by the owner unless the corresponding fees enumerated above be fully paid to the Municipal Treasurer or his duly authorized representatives thereof;

SECTION 3. Violation of this Ordinance or parts hereof shall be fined the amount of ₱100.00 to ₱500.00 or imprisonment of 10 to 30 days or both such fine and imprisonment at the discretion of the court;

SECTION 4. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 5. This Ordinance shall take effect ten days after its passage;
