The calling of the roll was performed by the Secretary with the members answering present when their respective names were called.

The minutes of the previous session was also read and there no objection so on motion of Hon. Ludovico Silang, duly seconded by Hon. Emelio Gregorio, the minutes stands as confirmed;

That, a draft Ordinance regulating the loading and unloading of fish commodities in this town was presented before the Sangguniang Bayan by Hon. Ludovico Silang for deliberation and approval. Same was set aside for the next session for further study and approval. UNANIMOUSLY APPROVED

That, the Municipal Secretary was instructed to write all barangay Captains to attend the special session set on November 10, 1986 to meet Mr. Marciano Balasbas, Provincial Fishery Officer, this Province to discuss matters affecting their problems in fishing in their respective barangays;

That, an Appropriation Ordinance appropriating the sum of ₱9,365.29 for salary adjustments of 12 teachers of the Bulalacao Municipal High School, GSIS Premiums and Cost of living allowance was also presented by Hon. That, Hon. Vice Mayor Ludovico Silang moved and duly seconded by Hon. Roland Pagcaliwagan that a resolution requesting the OIC Provincial Governor, Calapan, this Province to include in the infrastructure program for Calendar year 1987, the cementing of the Provincial road, this municipality.

APPROPRIATION ORDINANCE NO. 7  
SUPPLEMENTAL BUDGET NO. 6  
FOR CALENDAR YEAR 1986

SECTION 1. There is hereby Appropriated the sum of ₱9,365.29 to be taken from the savings of National Aid for salary adjustment of 12 teachers, Premiums and cost of living allowance of One (1) teacher of the Bulalacao Municipal High School starting from the month of November to December 1986, and transferring the sum of ₱39,582.78 from the stimated income of Infrastructure fund for Calendar year 1986 which has not been appropriated for the construction of fish port at Campaasan, this municipality;

SECTION 2. This Ordinance shall take effect immediately;

RESOLVED, FURTHER, that copies of this Appropriation Ordinance be forwarded to the Provincial Budget Officer, Calapan, Oriental Mindoro for review and Approval;
