The session was suspended on motion of Hon. Wilfredo Alejandro, duly seconded by Hon. Sanny Madra to intertain the barangay Captains and fishermen who are invited to attend the session.

The letter of the residents of Sitio Tabok regarding their problems in fishing was read by Barangay Captain of Poblacion, Dominador del Rosario. Mostly of the complain of the fishermen is about rampant illegal fishing in this municipality through explosive of dynamite used not only by individual persons but also committed by fishing boat. When the opinion of the INP Station Commander was asked regarding the complain of fishermen, he said a motor banca is under construction to be used by them in seacome patrol. However, while waiting for the motor banca, they are trying to patrol by using private motor boat but their problem is gasoline.

The officer-in-charge of the Bureau of fisheries which is expected to attend the session has not showed-up so, the barangay captains and fishermen left the session hall at 11:00 AM.

The session was resumed at 11:10 to take-up matters for deliberation and approval... UNANIMOUSLY APPROVED

WHEREAS, abundant fish is brought to town by fish dealers every day;

WHEREAS, reports received by this office said, that those fish sold to fish dealers and consumers here is caught by illegal means;

WHEREAS, the Municipal officials of this town are not in a position to identify whether fish sold here is caught through explosive of dynamite or not;

NOW THEREFORE, resolved as it is hereby resolved, to request the Officer-Incharge, Bureau of Fisheries, Calapan, Oriental Mindoro to assign offfield personnel in the municipality of Bulalacao to determine whether fish caught and sold to fish dealers and consumers in this town is caught by illegal means or not;

RESOLVED, FURTHER, that copies of this resolution be furnished, the Officer-Incharge, Bureau of Fisheries, Calapan, Oriental Mindoro for consideration.
