REQUESTING THE HONORABLE JUDGE, REGIONAL TRIAL COURT, ROXAS BRANCH, ROXAS, ORIENTAL MINDORO TO ORDER THE BUREAU OF LANDS, DENR, SAN MARIANO, ROXAS, ORIENTAL MINDORO TO RELOCATE THE BOUNDARIES OF LOT NO. 671, 670 AND THE PUBLIC MARKET, BULALACAO, ORIENTAL MINDORO

"WHEREAS, portion of Lot No. 671 is under court litigation as it is claimed by both Eusebio Contreras and Jose Macaya;

"WHEREAS, the municipal government has long wanted to ascertain the boundaries between Lot No. 670 and 671 in order to rightly determine the exact location of the area covered by the public market;

"WHEREAS, since said lot is under court litigation, surveying by any private surveyor is not allowed as this is sub judice;

"WHEREAS, development project and plans for the public market of this municipality are withheld due to uncertainty of the boundaries between Lot No. 670, 671 and the public market;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED to request the Honorable Judge, Regional Trial Court, Branch 43, Roxas, Oriental Mindoro to order the Bureau of Lands, DENR, San Mariano, Roxas, Oriental Mindoro to relocate the boundaries of Lot Nos. 670, 671 and the public market, Bulalacao, Oriental Mindoro;
