ORDINANCE NO. 6

AN ORDINANCE ADOPTING THE CODE OF GENERAL ORDINANCES OF BULALACAO, ORIENTAL MINDORO

WHEREAS, Municipal Ordinances have been scattered in numerous volume of our minute books and to look for them when needed has often been a cumbersome and tedious task;

WHEREAS, compilation of all existing Ordinances and up-dating them is necessary for the purpose of making it responsive to the present needs of the municipality;

WHEREAS, in the various stages of the codification of all the Ordinances this Body acknowledge the significant contributions made by other agencies of invaluable support and interest;

WHEREAS, this codified general Ordinances shall be known as the "CODE OF GENERAL ORDINANCES OF BULALACAO, ORIENTAL MINDORO."

NOW, THEREFORE, on motion of Hon. Emilio T. Gregorio, duly seconded by all members present, resolve as it is hereby resolved, to adopt as it is hereby adopted the Code of General Ordinances of Bulalacao, Oriental Mindoro with the content as follows:

Chapter X - Regulations on Business or Trade Activities


Chapter XI - Miscellaneous Provisions






