REQUESTING HONORABLE SECRETARY ALFREDO BENGSON, DEPARTMENT OF HEALTH, QUEZON CITY TO TAKE NECESSARY ACTION FOR THE SPEEDY CONSTRUCTION OF THE BULALACAO COMMUNITY HOSPITAL, BULALACAO, ORIENTAL MINDORO

WHEREAS, the Bulalacao 10-bed Community Hospital was constructed a year ago, the ground breaking ceremony of which was witnessed by the Secretary of the Department of Health, Secretary Alfredo Bengson;

WHEREAS, said construction was stopped for unknown reasons months ago;

WHEREAS, as per ocular inspection conducted by our technical staff the accomplishment of work was estimated at 40% more or less, as of the time construction stopped;

WHEREAS, the completion of this community Hospital is of vital importance to this municipality particularly to those who cannot afford to hire to Roxas District Hospital, the nearest to the place about 48 kms. away, not to mention the bad condition of the road;

WHEREAS, this project is part of the PRO-POOR Program for Low-Income-Municipality;


NOW, THEREFORE, resolved as it is hereby resolved, to request Secretary Alfredo Bengson, Department of Health to take necessary action for the speedy construction of Bulalacao Community Hospital;


RESOLVED, FURTHER, that copies of this resolution be furnished the Honorable Secretary Alfredo Bengson, Department of Health, Quezon City, the PRO-POOR Secretariat, 9th Floor Sectoral Liaison Office, the Presidential Management Staff, PMS Building, Malacanang, Manila, the Provincial Health Office, Calapan, Oriental Mindoro, Congressman Jesus M. Punzalan, House of Representatives, Quezon City and her excellency President Corazon C. Aquino, Malacanang, Manila, for proper action.


