RESOLUTION REQUESTING SENATOR ALBERTO G. ROMULO, SENATE OF THE PHILIPPINES TO EXTEND ASSISTANCE IN THE CONSTRUCTION OF NASUCOB-BAGACAY-IMBUYUNGAN-CAWACAT FARM TO MARKET ROAD, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Bulalacao is a fifth class municipality and classified as PRO-POOR municipality under Presidential Proclamation No. 390;

"WHEREAS, Barangay Nasucob produces the greatest bulk of rice and garlic in this municipality and its farmers suffer the difficulty of getting their products to the market;

"WHEREAS, the distance of this proposed farm to market road is approximately four (4) kilometers and the target beneficiaries are about two thousand (2,000) marginal farmers;

"WHEREAS, the construction of farm to market road in Barangay Nasucob would facilitate rapid movement of farm commodities, trigger development and, thus helping the marginal farmers emancipated from the quagmire of poverty;

"WHEREAS, it is firmly believed that the good Senator will give his support and approval;

WHEREFORE, upon motion duly seconded, be it:

RESOLVED TO REQUEST, as it hereby requests, Hon. Alberto G. Romulo, Senate of the Republic of the Philippines, Manila to extend assistance in the construction of Nasucob-Bagacay-Imbuyungan-Cawacat farm to market road, Bulalacao, Oriental Mindoro;
