" RESOLUTION NO. 93-05-027

RESOLUTION REQUESTING THE HONORABLE VICENTE C. SOTTO III, SENATE OF THE REPUBLIC OF THE PHILIPPINES, MANILA TO ASSIST THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE CONSTRUCTION OF ABC (ASSOCIATION OF BARANGAY CAPTAINS) HALL

"WHEREAS, Section 491 of Republic Act No. 7160 provides that there shall be an organization of all barangays to be known as the liga ng mga barangay for the primary purpose of determining the representation of the Liga in the sanggunian, and for ventilating, articulating and crystallizing issues affecting barangay government administration and securing, through proper and legal means, solutions thereto;

"WHEREAS, at present, the Association of Barangay Captains, Bulalacao, Oriental Mindoro lacks an office where it can regularly hold its meetings and plan its programs for the establishment of stronger ties between them (barangays) and promote the welfare of the barangay inhabitants;

"WHEREAS, it is beyond this Municipality's financial capability to construct an ABC Hall and we are optimistic that the Chairman of the Senate Committee on Local Government, a former local government official himself, will give due consideration to the request embodied in this resolution;

WHEREFORE, upon motion duly seconded, be it:

RESOLVED, to request as it hereby requests the Hon. Vicente C. Sotto III, Senate of the Republic of the Philippines, Manila to assist the Municipality of Bulalacao, Oriental Mindoro in the construction of ABC (Association of Barangay Captains) Hall;

RESOLVED FURTHER, to submit copies of this resolution to Hon. Vicente C. Sotto III, Senate of the Republic of the Philippines, Manila for his information, consideration and kindest approval.
