" WHEREAS, effective and efficient delivery as well as implementation of various health programs lamentably suffer due to lack of adequate number of physicians who will attend the sickly constituents of this Municipality;

" WHEREAS, the Sangguniang Bayan, cognizant of the sad plight of the poor citizens, humbly seeks the attention of the proper authorities in the Department of Health to address this particular problem that challenges the Department's mission and vision of rendering continuous health services to the poor majority;
